M.U.F.C. REGISTER

This is the Official Register of Members of the incorporated association known as “Melbourne University Football Club Inc.” Registered Number A0021824. The Register is the register of members as at January, 2014

PART A – REGULATORY OBLIGATIONS

This Register is maintained in accordance with the Club’s regulatory and constitutional obligations as set out below.

(a) Associations Incorporation Reform Act 2012

Division 3—Register of members

S.56 Register of members

(1) An incorporated association must keep and maintain a register of members in accordance with this section.

Penalty: 10 penalty units.

(2) The register of members must contain the following information about each person who is a member of the association—

- (a) the person's name and address;
- (b) if applicable—the class of membership of the person;
- (c) the date on which the person became a member of the association.

(b) Melbourne University Sports Association Constitution

Access to Membership - Rule 5.2

Access to Club membership is limited to:

- (a) currently enrolled students and graduates of the University who have paid the membership fee set by each club from time to time;
- (b) currently enrolled students and graduates of other Universities who have paid the membership fee as set by the club from time to time;

- (c) those persons ordinarily ineligible who are, following an application from the Club, deemed eligible by the Director.

(c) **Melbourne University Football Club Inc. Rules (the Constitution)**

A. Eligibility and Categories of Membership

(i) General Membership - Rule 4

- (1) A natural person who is or is eligible to become a member of the Melbourne University Sports Association and is approved for membership as provided in these Rules is eligible to become a Member on payment of the annual subscription.
- (2) A nomination of a person for membership of the Club shall be made in writing by any of the Teams in the form as determined by the Board from time to time; shall be lodged with the General Secretary; and shall be accompanied by the sum payable as the annual subscription.
- (3) As soon as practicable after the receipt of a nomination and the annual subscription, the nomination shall be referred to the Board.
- (4) Upon a nomination being referred to the Board, the Board shall determine whether to approve or to reject the nomination.
- (5) If the nomination is approved by the Board, the General Secretary shall enter the nominee's name in the Register of members kept by him and upon the name being so entered, the nominee becomes a Member.
- (6) If the nomination is rejected by the Board, the General Secretary shall, with as little delay as possible, notify the nominee in writing that his nomination was not approved for membership of the Club and return payment of the annual subscription
- (7) A right, privilege or obligation of a person by reason of his membership of the Club is not capable of being transferred or transmitted to another person; and terminates upon cessation of his membership whether by death, resignation, failure to renew or otherwise.

(ii) Life Membership – Rule 5

Notwithstanding anything contained in Rule 4, a person may be appointed by the Board as a Life Member. In order to be recommended for appointment as a

Life Member a person must have given no less than eight years outstanding service to the Club as a Member of the Board or a Committee or Team Player, including three years' service in an administrative capacity. Upon appointment, a Life Member shall be presented with a medallion by the Board.

(iii) Honorary Members – Rule 6

Notwithstanding anything contained in Rule 4, the Board may, in special circumstance, admit as an Honorary Member any person whom it deems fit. Such membership is current for the financial year in which such membership was granted.

B. Maintenance of Register of Members - Rule 10

The General Secretary shall keep and maintain a register of members in which shall be entered the full name, address and date of entry of the name of each member and the register shall be available for inspection by Members at the clubrooms of the Club.
